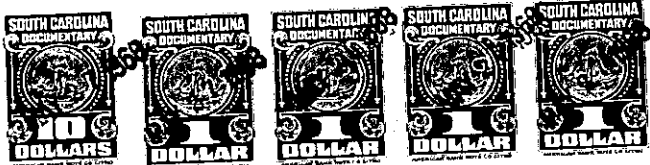
All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the south side of Highland Avenue (formerly Highlawn Avenue) and being known and designated as Lot No. 3, Block F, on plat of Riverside Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book "K", at Pages 281 through 284, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Highland Avenue at the joint front corner of Lots Nos. 2 and 3 and running thence along said Avenue S. 79-45 E. 50 feet to an iron pin; thence along the joint line of Lots Nos. 3 and 4 S. 10-15 W. 125 feet to an iron pin; thence N. 79-45 W. 50 feet to an iron pin; thence along the joint line of Lots Nos. 2 and 3 N. 10-15 E. 125 feet to the point of beginning.
