ALL that certain piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, situate on the Southern side of Rockvale Drive, being shown and designated as Lot No. 93 on a Plat of Section 1 of ROCKVALE, recorded in the RMC Office for Greenville County, S. C., in Plat Book QQ, page 108, and having according to said plat the following metes and bounds, to wit:
