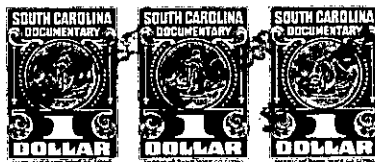
KNOW ALL MEN BY THESE PRESENTS, that I, Ward S. Stone, of Greenville County,

in consideration of One Thousand, Five Hundred and No/100-----(\$ 1,500.00)----- Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Chas. A. Mundy, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville; near the City of Greenville, being known and designated as Lot No. 107 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of French Lane, joint front corner of Lots Nos. 106 and 107, and running thence along the joint line of said lots, N. 79-36 E. 149.0 feet to an iron pin on the rear line of Lot No. 96; thence along the rear line of that lot and continuing along the rear line of Lot No. 95, N. 15-46 W. 95 feet to an iron pin at the joint rear corner of Lots Nos. 95 and 94; thence along the line of Lot No. 108, S. 71-44 W. 125.4 feet to an iron pin on the eastern side of French Lane; thence along the eastern side of French Lane, following the curvature thereof, the chords being S. 7-43 E. 40 feet, and S. 9-55 W. 35 feet, to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665, at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record. This lot is subject to a 10-foot sanitary sewer easement as shown on the recorded plat.
