KNOW ALL MEN BY THESE PRESENTS, That I, Sara G. Williams

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Detect, Inc., its Successors and Assigns, forever:

ALL my right, title and interest in and to the following described property:

Tract 1 ALL that certain piece, parcel and lot of land situate, lying and being on the South side of Trace Street and on the East side of Neely Ferry Road (South Street) in the Town of Simpsonville, County of Greenville, State of South Carolina, and having the following courses and distances to-wit:
