KNOW ALL MEN BY THESE PRESENTS, that I, William Green, of Greenville County

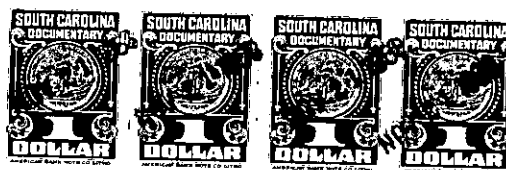
in consideration of Seventeen Hundred Fifty and No/100 (\$1750.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jewel A. Posey, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 4 of a subdivision known as Green Pastures as shown on plat thereof prepared by Carolina Engineering & Surveying Co., March 20, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book III at Page 133 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on a bend of Stacey Drive, joint front corner of Lots 4 and 5 and running thence along the joint line of said lots, S. 14-52 W. 153.3 feet to an iron pin at the joint rear corner of Lots 20 and 21; thence along the rear line of Lot 20, N. 64-10 W. 122.4 feet to an iron pin at a joint rear corner of Lots 4 and 20; thence N. 27-32 W. 57.7 feet to an iron pin at a rear corner of Lot 3; thence along a line of that lot, N. 62-28 E. 150.0 to an iron pin on Stacey Drive; thence along the southwestern side of Stacey Drive, following the curvature thereof, the chord being S. 69-12 E. 50 feet to the beginning corner;
