the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain,  
sell and release unto A. J. PRINCE BUILDERS, INC., its successors and assigns  
forever:

ALL that certain piece, parcel or lot of land, situate, lying and being  
in the State of South Carolina, County of Greenville, on the Eastern side  
of Old Dunham Bridge Road, being shown and designated as Lot No. 68 on a  
Plat of VARDRY-VALE, Section 1, made by Campbell & Clarkson, Surveyors,  
dated November 15, 1968, and recorded in the RMC Office for Greenville  
County, S. C., in Plat Book WWW, page 40, and having according to said  
plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern side of Old Dunham Bridge Road  
at the joint front corners of Lots Nos. 68 and 69, and running thence  
along the common line of said lots, S. 70-24 E., 150 feet to an iron pin;  
thence N. 19-36 E., 80 feet to an iron pin; thence along the common line  
of Lots Nos. 67 and 68, N. 70-24 W., 150 feet to an iron pin on Old Dunham  
Bridge Road; thence along the Eastern side of Old Dunham Bridge Road,  
S. 19-36 W., 80 feet to an iron pin, the beginning corner.

The above described property is a part of the same conveyed to the Grantor  
by deed of Henry C. Harding Builders, Inc., recorded in the RMC Office  
for Greenville County, S. C., in Deed Book 853, page 430, and is hereby  
conveyed subject to drainage easements, setback lines, roadways, rights  
of way, easements, of public record, and to restrictive covenants appli-  
cable to Vardry-Vale, Section 1, recorded in the RMC Office for said
