ALL water lines, mains, valves and appurtenances installed and located in under or along Circle Drive and Piney Ridge Drive, County of Greenville, State of South Carolina including approximately 270 feet more or less of 1" Galv. Pipe, 300 feet more or less of 3/4" Galv. Pipe, 500 feet more or less of 1" or 2" Galv. Pipe (on Piney Ridge Drive) and is shown on a drawing entitled, "Z. C. Grier to Wade Hampton Water and Sewer District," attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.

It is the intention of the Grantor to quitclaim to the Grantee all of his right, title and interest in and to the water lines or any equipment attached thereto or used in connection therewith which he may presently have.
