ALL that certain part and parcel of land lying in the Town of Mauldin, County of Greenville, State of South Carolina, and shown as Lot 78 on a plat of Bishop Heights, by Ethan C. Allen, dated January, 1966, and recorded in the R.M.C. Office for Greenville County in Plat Book BBB, Page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Garrett Street, joint front corners of lots 77 and 78 and running thence N. 64-18 W., 200 ft. to an iron pin; thence N. 25-42 E., 105 ft. to an iron pin; thence S. 64-18 E., 200 ft. to an iron pin on Garrett Street; thence with said Street, S. 25-42 W., 105 ft. to the point of beginning.
