E.P.Riley, E.P. Riley, Jr., and R. W. Riley, their heirs and assigns forever:

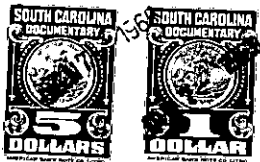
