to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto JAMES C. LEWIS, JR., and RENA MAE B. LEWIS:

All that piece, parcel or lot of land situate, lying and being on the Western side of Wakewood Way near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 28 as shown on a plat of Imperial Hills, prepared by C. C. Jones, dated August 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 35, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Wakewood Way at the joint front corner of Lots Nos. 27 and 28 and running thence with the line of Lot No. 27 S. 68-0 W. 149.8 feet to an iron pin; thence with the rear line of Lot No. 32 N. 34-08 W. 87.2 feet to an iron pin; thence with the rear line of Lot No. 31 N. 11-21 W. 45 feet to an iron pin at the joint rear corner of Lots Nos. 28 and 29; thence with the line of Lot No. 29 N. 79-46 E. 172.1 feet to an iron pin on the Western side of Wakewood Way; thence with the Western side of Wakewood Way S. 8-00 E. 15 feet to an iron pin; thence continuing with the Western side of Wakewood Way S. 18-17 E. 80 feet to the point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

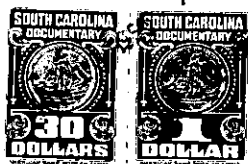
