DONALD C. ARMSTRONG AND SANDRA M. ARMSTRONG, THEIR HEIRS AND ASSIGNS, FOREVER:

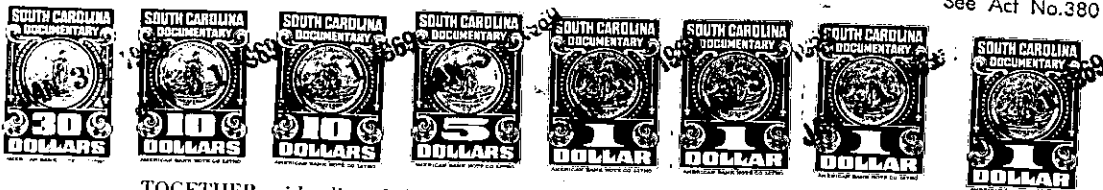
