All that piece, parcel or lot of land lying and being in Butler Township, situate near the City of Greenville County of Greenville, State of South Carolina and being known and designated as Lot 6, on the Eastern side of Fairlane Circle, part of a subdivision known as Laurel Heights, and being more particularly described according to plat recorded in the RMC Office for Greenville County in Plat Book KK, at page 33, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at joint front corner of Lots 6 and 7 and running thence along the line of these lots, S. 82-47 E. 150 feet to an iron pin, thence N. 7-13 E., 148.9 feet to an iron pin at rear of lots 6 and 5 and running thence S. 71-47 W. 172.1 feet to an iron pin on the Eastern side of Fairlane Circle, which line is curved, the chord of which is S. 0-03 E. 42.9 feet to an iron pin; thence continuing on Fairlane Circle, S. 7-13 W. 32.1 feet to an iron pin the point of beginning.

As a part of the consideration the grantees assume and agree to pay that certain mortgage given to Caroling Federal Savings and Loan Association as recorded in the RMC Office for Greenville County in Mortgage Book 730 at page 392 and having a balance of \$3,000.00. The grantees also assume that certain mortgage given to Levis L. Gilstrap as recorded in the RMC Office for Greenville County in the amount of \$9,000.00.
