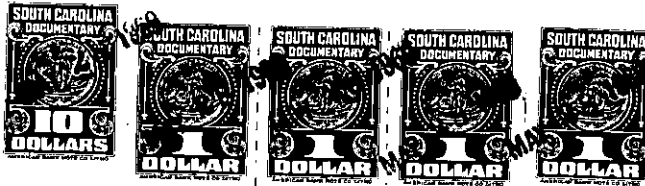
The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground.
