the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William F. Davis and R. W. Riley, their heirs or assigns, forever.

ALL that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being shown and designated on plat prepared by E. H. Walker, Jr., dated May, 1969, and having the following metes and bounds, to-wit:
