and the premises herein, ----- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto J. F. Littleton, his heirs and assigns, forever;

All that certain piece, parcel or lot of land, situate, lying and being in Greenville County, State of South Carolina, being Lot 37 of Casa Loma Estates, as shown on plat recorded in the RMC Office for Greenville County in Plat Book S, Page 65, and a strip of land lying between said Lot and Merrydale Lane, being shown on plat entitled Property of Richard C. Buchanan made by C. C. Jones, Engineer, February 23, 1963, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Merrydale Lane, corner of Lot 8 (on plat of Pinehurst Subdivision recorded in Plat Book PP, at Page 39 of the RMC Office for Greenville County) and running thence with said Lot S. 19-34 E. 83.5 feet to an iron pin at corner of Lot 36 (on Casa Loma Estates plat); thence with the line of said Lot S. 49-47 W. 205.6 feet to an iron pin on the northeast side of Courtney Circle; thence with the curve of said Street N. 47-23 W. 69.9 feet to an iron pin, corner of Lot 38; thence with the line of said Lot N 34-47 E. 184.5 feet to an iron pin, the rear corner of Lots 37 and 38; thence with a new line N. 9-31 E. 17.9 feet to an iron pin on the south side of Merrydale Lane; thence with said Street S. 90-29 E. 77 feet to the beginning corner.
