KNOW ALL MEN BY THESE PRESENTS, that I, Margaret M. Suber

in consideration of One Dollar----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. C. B. Containers, Inc., its successors and assigns forever:

All that certain piece, parcel or strip of land situate, lying and being in the State of South Carolina, County of Greenville as is more fully shown on a plat of Property of Margaret M. Suber dated January 5, 1968, prepared by Carolina Engineering and Surveying Co. and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of U. S. Highway # 123, which pin is located N. 83-13 W. 36.3 feet from property of Godsey, and running thence N. 3-07 E. 20 feet to an iron pin; running thence N. 86-54 W. 253.6 feet to an iron pin; running thence N. 88-58 W. 255.1 feet to an iron pin; running thence S. 1-51 E. 20 feet to an iron pin; running thence approximately S. 88-58 E. 508.7 feet, more or less, to the point of beginning.

It is the intention of this deed to convey to W. C. B. Containers, Inc. all of the property located on the northern side of U. S. Highway # 123 between its right-of-way and the property now owned by W. C. B. Containers, Inc. The right-of-way granted to the South Carolina State Highway Department by J. R. Martin, Jr. by deed dated July 20, 1941 on file in the South Carolina State Highway Department, Columbia, S. C. conveys only a 200-foot right-of-way. However, the plats prepared by the South Carolina State Highway Department which are identified as Docket 23.247 Stas. 132 + 83 to 163 + 45 show a 20-foot offset as is hereinabove described. The South Carolina State Highway Department never acquired the 20-foot strip and the purpose of this deed is to convey any interest of the grantor in said strip to the grantee herein.
