That I, H. H. COX, R. F. C. OLLIE FARNSWORTH

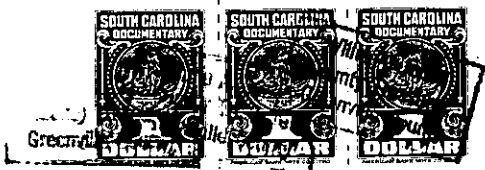
