KNOW ALL MEN BY THESE PRESENTS, That Arthur Deanhardt, H. H. Bradley, and Jack Holliday, Trustees of Woodman of the World, Camp No. 14 for South Carolina in the State aforesaid, in consideration of the sum of One and No/100 (\$1.00)-----

-----Dollars and the premises. to us ----- in hand paid at and before the sealing of these presents by T. J. Jacks and Freddie Z. Jacks -----

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. J. Jacks and Freddie Z. Jacks, their heirs and assigns, forever:

ALL that certain piece, parcel or lot of land in the State of South Carolina, Greenville County, Grove Township, containing .32 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at a stone 3 X in cross roads near Reedy Fork Church and running thence S. 87-25 E. 355.74 feet to a stone 3 X.N.M.; thence S. 6-25 W. 79.20 feet to a pin 3 X.N.M. in center of road; thence with the road, N. 75 W. 358.38 feet to the beginning corner and lying by lands now or formerly of Reedy Fork Church lot, Reedy Fork School lot, and lands of T. M. Griffin.

This is the same property conveyed by T. M. Griffin to Griffin Camp W.O.W. No. 346 for South Carolina by deed dated September 25, 1917, and recorded in the R.M.C. Office for Greenville County in Deed Book 35, Page 418. The said Griffin Camp W.O.W. No. 346 for South Carolina was consolidated and merged with Woodman of the World Camp No. 14 for South Carolina on April 1, 1967, and through such consolidation or merger, all property, real, personal and mixed, belonging to Griffin Camp W.O.W. No. 346 for South Carolina became the property of Woodman of the World Camp No. 14 for South Carolina.

It is the intent and purpose of this deed to quit claim any and all right, title and interest in and to the above described property as well as any property and rights which may have been acquired by Griffin Camp W.O.W. No. 346 for South Carolina under Item 6 of the Last Will and Testament of T. M. Griffin, which is recorded in the Probate Court for Greenville County, South Carolina, in Apartment No. 284, File 4, to the Grantees herein, their heirs and assigns, forever.
