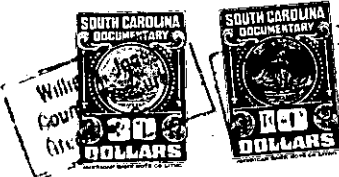
in consideration of Twenty Thousand Dollars and No/100 (\$20,000.00)-----Dollars,
