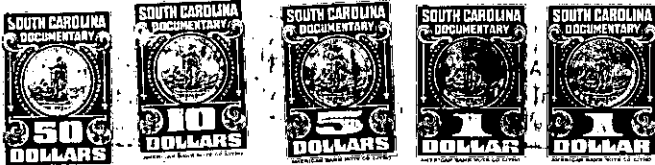

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township on the eastern side of South Carolina Highway No. 291 and being known and designated as a portion (the southern half) of Lot 8 as shown on a Plat of J. H.
