the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

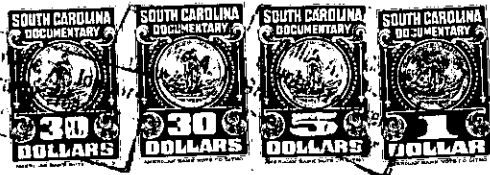

All that lot of land situate on the East side of Pimlico Road and on the South side of Shallowford Road in the City of Greenville, Greenville County, South Carolina, being shown as Lot no. 506 on Plat of Section "D" of Gower Estates, made by Campbell & Clarkson, Surveyors, May 1964, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book RR, Page 192 and 193, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East Side of Pimlico Road at the joint corner of Lots 506 and 507 and runs thence along the line of lot 507, S. 87-55 E., 140 feet to an iron pin; thence along the line of Lot 505, N. 1-04 W., 171.1 feet to an iron pin on the South side of Shallowford Road; thence along Shallowford Road, N. 88-01 W. 115 feet to an iron pin; thence with the curve of Shallowford Road and Pimlico Road (the chord being S. 45-13 W., 341.2 feet) to an iron pin on the East side of Pimlico Road; thence along Pimlico Road, S. 1-33 E., 125.9 feet to an iron pin; thence continuing along said Road S 2-35 W 20 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, set back lines, roadways, easements and rights-of-way, if any, appearing of record, on the premises, or on the recorded plat, which affect the property hereinabove described.
