ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Buckhorn Road being shown and designated as Lot No. 19 on a Plat of GRANDVIEW HILLS, made by R.B. Bruce, Engineer, recorded on March 31, 1969, in the RMC Office for Greenville County, S. C., in Plat Book WWW, page 52, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeastern side of Buckhorn Road at the joint front corners of Lots Nos. 19 and 20, and running thence N. 32-36 E., 238.4 feet to an iron pin; thence S. 50-32 E., 96.5 feet to an iron pin; thence S. 9-54 W., 231.3 feet to an iron pin on Buckhorn Road; thence with the Northeastern side of Buckhorn Road, N. 63-53 W., 131 feet to an iron pin; thence continuing with said side of Buckhorn Road, N. 56-04 W., 55 feet to an iron pin, the beginning corner.
