As a part of the consideration for this deed, the Grantor assigns and transfers unto the Grantee all his right, title and interest in and to any escrow deposits maintained by the above named mortgagee in connection with mortgage loan covering the above described property.

The Grantee agrees to pay Greenville County and City of Greenville property taxes for 1969 and subsequent years.
