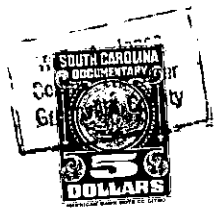
Lots 22 and 23 Laurel Drive:

BEGINNING on Laurel Drive, 260 feet, more or less, from intersection of Fairview Road and Laurel Drive, at an iron pin at joint front corners of Lots 25 and 23 and running thence 195.8 feet with the line of said Drive to an iron pin at joint front corners of Lots 22 and 20; running thence 165.7 feet with the side line of Lot 22 to an iron pin at joint rear corners of Lots 19, 20, 21 and 22; running thence 139.4 feet with the rear lines of Lots 21 and 24 to an iron pin at joint rear corners of Lots 23, 24 and 25; running thence 168.9 feet with the side line of Lot 23 to the iron pin at joint front corners of Lots 23 and 24 on Laurel Drive, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 30 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only.

THIS conveyance is subject to all easements and rights of way of record.
