ALL that certain lot of land in the State of South Carolina, County of Greenville, lying on the southern side of a proposed street, shown on a plat entitled "Property of Hattie Washington", dated January 3, 1961, prepared by C. O. Riddle, Registered Land Surveyor, and further described according to said plat as follows:

BEGINNING at a point on the southeastern side of a proposed road, said point being 172 feet in a southwesterly direction from the corner of property now or formerly owned by P. D. Hill and running thence S-44-10 E. 160.7 feet to an iron pin; thence S-45-50 W. 136 feet to an iron pin, which point is 429.4 feet in a northeasterly direction from a stone; thence N. 44-10 W. 160.7 feet to iron pin, on the southeastern side of a proposed road; thence along the southeastern side of the proposed road N. 45-50 E. 136 feet to the point of beginning, containing one-half acre, more or less.
