KNOW ALL MEN BY THESE PRESENTS, that We, William R. Timmons, Jr. and W. T. Patrick

in consideration of correction of prior deeds ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Eugene E. Stone, III, his heirs and assigns forever:

All that certain piece, parcel or triangular lot of land situate, lying and being in the State of South Carolina, County of Greenville, being a portion of the property shown on the County Tax Maps at Sheet 183.3, Block 1, Lot 1 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the joint property lines belonging to the grantors and the grantee where said joint line intersects the north side of the right-of-way for By-Pass Highway 291 (this iron pin being about 12 feet in the direction S. 66-11 W. from this point as previously located) and running thence along the joint line of said properties, (as re-located), N. 78-57 W. 78.5 feet to an iron pin; thence S. 23-49 E. 44.9 feet to an iron pin on the north side of the right-of-way for By-Pass Highway 291; thence along the north side of said right-of-way, passing an iron pin at 12 feet, N. 66-11 E. 64.3 feet to the beginning corner. Being a portion of the same property conveyed to us by deed recorded in the R. M. C. Office for Greenville County in Deed Vol. 473 at Page 100.

This deed is intended to correct certain errors in the description contained in a deed from the same grantors to the same grantee dated April 30, 1970, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 889 at Page 267. The description contained in that deed was based upon an erroneous location of the joint property line between the grantors and the grantee. The property conveyed by that deed has been reconveyed to the grantors herein by a deed to be recorded simultaneously with this deed.
