all that piece, parcel or tract of land, situated on the southeast side of Riverview Drive and on the northeast side of Knollview Drive, near the city of Greenville in Greenville County, S.C., shown as lot no. 118 on plat of Liverdale, made by Dalton & Neves, Engineers, July, 1957, recorded in the REC office for Greenville County, S.C., in plat book KK, page 107, and having according to said plat the following metes and bounds to wit:
