and having according to said plat the following metes and bounds, to-wit:

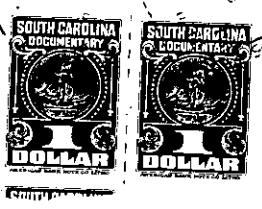
BEGINNING at an iron pin, the joint corners of the Grantees' property and the
