Frank D. Larkins and Katheren G. Larkins, their heirs and assigns, forever:

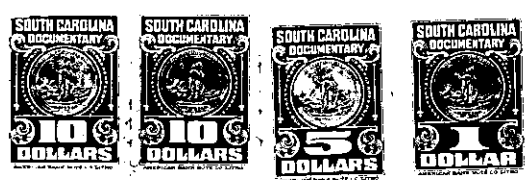
