in consideration of -----One Thousand Five Hundred and No/100 (\$1,500.00)----- Dollars,

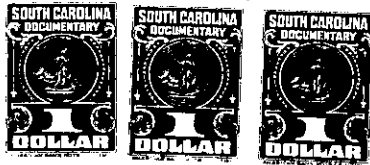

All that certain piece, parcel or lot of land on the north side of Ashmore Bridge Road, in the County of Greenville, State of South Carolina, being a portion of Lot 5 of Tar Acres, plat of which is recorded in the RMC Office for Greenville County in Plat Book PPP, at Page 13, and being more particularly described as Lot 5-A, containing 0.43 acre, on a plat of Property of P. Warren McLeod and Arthur W. & Joyce A. Irvin, Greenville Co., S. C., made by T. H. Walker, Jr., Jan. 11, 1971, recorded in the RMC Office for Greenville County in Plat Book 4-H, at Page 199, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Ashmore Bridge Road, at the joint front corner of Lot 4 and Lot 5-A, and running thence along the common line of said Lots N. 3-25 E. 275 feet to an iron pin in the line of Lot 15, joint rear corner of Lots 4 and 5-A; thence along the rear lines of Lot 15 and Lot 16 S. 86-35 E. 68 feet to an iron pin, joint rear corner of Lots 5-A and 5-B; thence running along the common line of Lots 5-A and 5-B S. 3-25 W. 275 feet to an iron pin on the north side of Ashmore Bridge Road; thence along the said Ashmore Bridge Road N. 86-35 W. 68 feet to the point of beginning.
