ALL that tract of land in the County of Greenville, State of South Carolina, and in Greenville Township, lying on both sides of a road known as Piney Road, near the City of Greenville, and according to a survey made by R. W. Dalton, December 21, 1959, containing 2.28 acres, and being described as follows:

BEGINNING at an iron pin in Piney Road at the corner of property now or formerly of Fred M. Crow, and running thence S. 12-0 W. 220 feet, crossing Piney Road to an iron pin; thence N. 83-0 W. 489 feet, passing an iron pin to center of branch; thence with the branch as the line N. 26-52 E. 233 feet to an iron pin at the corner of property now or formerly owned by Fred M. Crow; thence with the line of said Crow property S. 83-00 W. 429 feet to the beginning corner.
