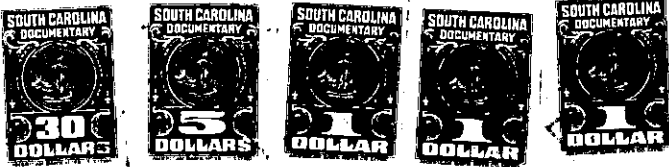
KNOW ALL MEN BY THESE PRESENTS, that George E. McCreight -----
