in consideration of Nine Thousand Five Hundred and no/100 (\$9,500.00) Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William R. Hueston and Ruth Hueston, their heirs and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of Great Glen Road, near the City of Greenville, S. C., being known and designated as Lot No. 24 on Plat of Del Norte Estates as recorded in the RMC Office for Greenville County, S. C., in Plat Book WWW, at pages 32 and 33 and having according to said plat the following metes and bounds, to-wit:

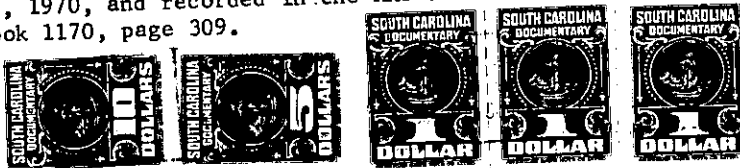
BEGINNING AT an iron pin on the northwesterly side of Great Glen Road, said pin being the joint front corner of Lots 24 and 25 and running thence with the common line of said Lots N 57-58 W 146.6 feet to an iron pin, the joint rear corner of Lots 24 and 25; thence S 30-55 W 102.3 feet to an iron pin, the joint rear corner of Lots 23 and 24; thence S 61-04 E 145.3 feet to an iron pin on the northwesterly side of Great Glen Road; thence with the northwesterly side of Great Glen Road N 27-32 E 3 feet to an iron pin, thence continuing with said Road N 31-13 E 92 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property.
