Beginning at a point on the Northwestern edge of Edgewood Drive at the joint front corner of Lots 14 and 15 and running thence along a line of Lot 14 N. 47-27 W 165.0 feet to a point; thence N. 42-33 E. 132.0 feet to a point on the Southwestern edge of a 50 foot street; thence along the Southwestern edge of said street S. 47-27 E. 140 feet to a point; thence along the curve of the Northwestern corner of the intersection of said 50 foot street and Knollwood Drive as the line, the chord of which is S. 2-27 E. 35.3 feet, to a point; thence along the Northwestern edge of Edgewood Drive S. 42-33 W. 107.0 feet to the beginning corner and being a portion of the property conveyed by Mary D.
