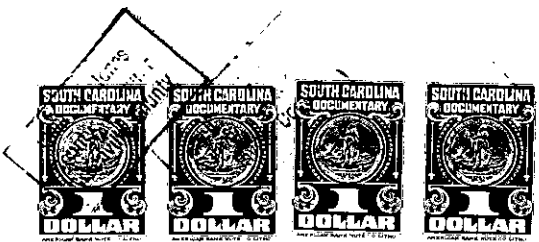

ALL that piece, parcel or tract of land containing 2.74 acres, more or less, in Greenville County, State of South Carolina, on the Eastern side of a dirt road leading North from Dalton Road, being shown and designated as Lot No. 3 on a Plat of Property of John B. Gwynn made by J. R. McClure, RLS, dated October 2, 1970, described as follows:

BEGINNING at an iron pin on the Eastern side of said dirt road at the joint front corners of Lots 3 and 3-A, and running thence along said joint line, S. 81-02 E., 400 feet to an iron pin in the line of Lot 9; thence with the line of Lot 9, S. 22-28 W., 287.0 feet to an iron pin; thence along the rear lines of Lots 1, 1-A, and 1-B, N. 88-46 W., 395.55 feet to an iron pin on the Eastern side of said dirt road; thence along the Eastern side of said Dirt road, N. 18-55 E., 337.45 feet to an iron pin, the point of beginning.

The above property is a part of the same conveyed to the Grantor herein by deeds recorded in Deed Book 892, page 182, and Deed Book 902, page 67, and is hereby conveyed subject to rights of way, easements, conditions, public roads and restrictive covenants reserved on plats and other instruments of public record and actually existing on the ground affecting said property.
