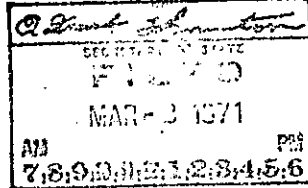

(1) Name of corporation Blue Ridge Rural Water Company, Inc. c/o S. B. Williams

(2) Address of corporation Route # 2, Greer, S. C. 29651 (Street, Number and City)

This corporation is a nonprofit organization which is financed in whole or in part by a loan made under the provisions of the Consolidated Farmers Home Administration Act of 1961, as amended and no part of the income or assets of which shall be distributed to its members.

(3) The purposes for which the corporation is organized are as follows:

a. To acquire, construct, maintain, operate and provide water distribution and supply facilities (and/or sewerage collection and disposal facilities) to individuals, farms, businesses, corporations and political subdivisions within the hereinafter described geographical area.

b. To effectuate the purposes contained in a. above, the corporation is to exercise all rights, duties, privileges and powers granted and vested into nonprofit corporations of like purpose created and existing pursuant to and by virtue of Act No. 1030 of 1964 General Assembly of South Carolina and amendments thereto.

(4) The period of duration of the corporation shall be perpetual (XXXXXXXXXXXXXXXXXXXX years)
