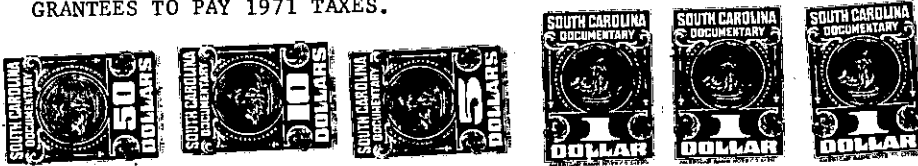

BEGINNING at an iron pin on the southwesterly side of Yancy Drive, said pin being the joint front corner of Lots 8 and 9, and running thence with the common line of said lots, S 80-35 W 176.8 feet to an iron pin; thence on a line through Lot 9, S 29-37 E, 172.8 feet to an iron pin on the northerly side of McCarter Avenue, said pin being the joint front corner of Lots 9 and 10; thence with the northerly side of McCarter Avenue N 66-48 E 104.1 feet to an iron pin at the intersection of McCarter Avenue and Yance Drive; thence on a curve, the chord of which is N 30-30 E 45.3 feet to an iron pin on the southwesterly side of Yancy Drive; thence with the southwesterly side of Yancy Drive, N 15-30 W 100.9 feet to an iron pin, the point of beginning.
