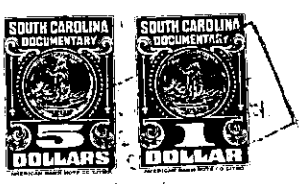
KNOW ALL MEN BY THESE PRESENTS, that I, W. H. McCrary
