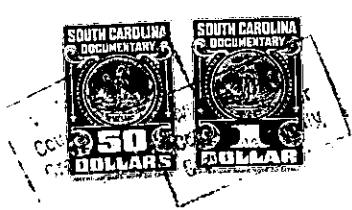
KNOW ALL MEN BY THESE PRESENTS, that RICHARD C. BUZUN and JOANNE M. BUZUN
