BUILDERS & DEVELOPERS, INC., their successors and assigns forever:

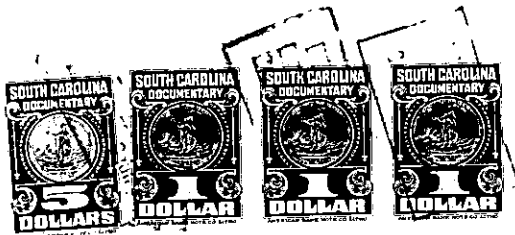
