County. State of South Carolina , and having the following metes and bounds, to-wit: BEGINNING at a rock in creek at the corner of land of G. W. Holtzclaw and C. B. Jackson; thence along the line of C. B. Jackson land, S. 16 1/3 E. 18.75 chains to stone in road separating this land from land now or formerly S. C. Dickson's; thence along said road S. 72 3/4 W. 20 chains to stone in road; thence N. 16 W. 22.40 chains to stone at corner of G. W. Holtzclaw's line; thence N. 82 1/2 E. 20. 20 chains to the beginning corner, and containing 40 1/2 acres, more or less. This being the same tract of land as conveyed to J. E. Flynn and John M.
