All that certain piece, parcel or lot of land situated, lying, and being in the County of Greenville and State aforesaid and being known and designated as a part of that 8.42 acres, more or less, of Lot 11, Piney Ridge Drive, on Plot of Property formerly of Widay M. Austin recorded in R. M. C. Office in Plat Book "II" at page 161 and being more particularly described as follows to wit:
