in consideration of THREE THOUSAND FIVE HUNDRED AND NO/100----- (\$3,500.00)----- Dollars,

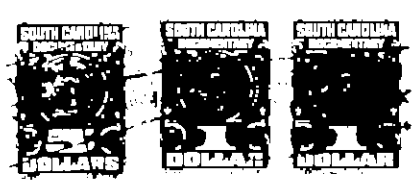

ALL that certain piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, about 7 miles Southwest of the City of Greenville, and being known and designated as Lot Number 46 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 193, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of Driftwood Drive at the joint corner of Lots 45 and 46 and running thence with the Northeastern side of Driftwood Drive N 34-24 W 346.5 feet to a point at the joint front corner of Lots 46 and 47; thence N 55-36 E approximately 268.7 feet to a point in a branch at the joint rear corner of Lots 46 and 47; thence with said branch as a line approximately S 7-22 E approximately 82 feet to a point in said branch; thence continuing with said branch approximately S 28-24 E approximately 89.1 feet to a point in said branch; thence still continuing with said branch approximately S 66-34 E approximately 119.8 feet to a point in said branch; thence still continuing with said branch approximately S 27-21 W approximately 58.8 feet to a point in said branch; thence still continuing with said branch approximately S 34-30 E approximately 50.9 feet to a point in said branch at the joint corner of Lots 45 and 46; thence S 55-36 W approximately 225.4 feet to a point on the Northeastern side of Driftwood Drive at the point of BEGINNING.
