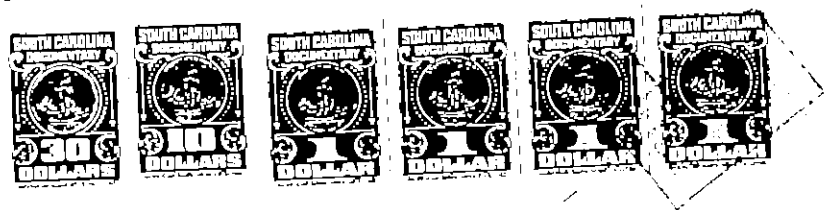
in consideration of Twenty-one Thousand Nine Hundred Fifty (\$21,950.00) Dollars,

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 2 on plat made by Carolina Engineering and Surveying Company, and having according to said plat the following metes, bounds, courses and distances, to-wit:

Beginning at an iron pin on the southeast side of Riley Road, the joint front corner of Lots 2 & 3, which iron pin is 1,218.9 feet southwest from the southeast corner of intersection of Welcome and Riley Roads; thence with the joint line of said lots S. 66-37 E. 186.2 feet to an iron pin; thence N. 25-13 E. 100.1 feet to an iron pin joint rear corner of Lots 1 & 2; thence with the joint line of said lots N. 66-50 W. 175.8 feet to an iron pin on the southeast side of Riley Road; thence with the southeast side of Riley Road S. 30-35 W. 100 feet to an iron pin, the point of beginning.
