ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in the City of Greenville, being located on the southeasterly side of North Church Street (formerly Elford Street) and having according to plat entitled Property of Greenville Memorial Auditorium, prepared by Dalton & Neves Co., Engineers, dated January, 1972, the following metes and bounds to-wit:

BEGINNING at an iron pin on the southeasterly side of North Church Street, which iron pin is located 54 feet northeast of the intersection of Manly Street and North Church Street, and running thence with the southeasterly side of North Church Street N. 48-05 E. 26.3 feet to an iron pin; thence S. 20-50 E. 34.4 feet to an iron pin; thence with the northerly edge of an alley S. 72-39 W. 23.7 feet to an iron pin; thence N. 91-02 W. 23.6 feet to the beginning corner.

This being a portion of the same property conveyed to the grantor herein by deed recorded in Deed Volume 397, at Page 80 in the RMC Office for Greenville County, and is shown on the Greenville County Block Book as Sheet 41, Block 2, Lot 11.
