LOIS G. RICHARDS, her heirs and assigns forever:

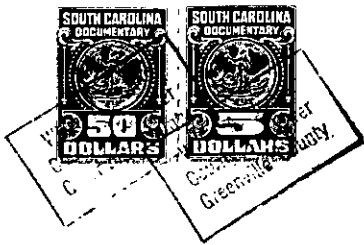
All that certain piece, parcel or lot of land in Greenville County, State of South Carolina,
