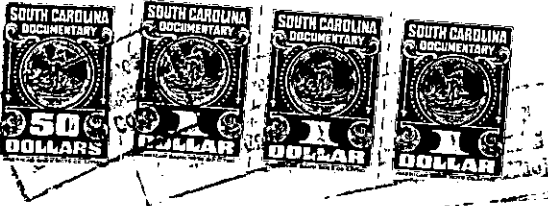
in consideration of Twenty-Six Thousand Five Hundred and No/100-----(\$26,500.00)-Dollars,
