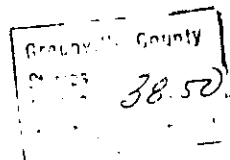
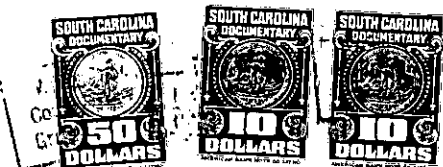
FRANKLIN D. CONRAD AND PATRICIA A. CONRAD, THEIR HEIRS AND ASSIGNS, FOREVER:
