in consideration of Eighteen Thousand One Hundred and No/100-----Dollars,

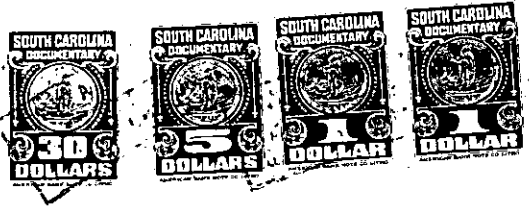
