unto PATRICIA S. DAVIDSON, her heirs and assigns forever:

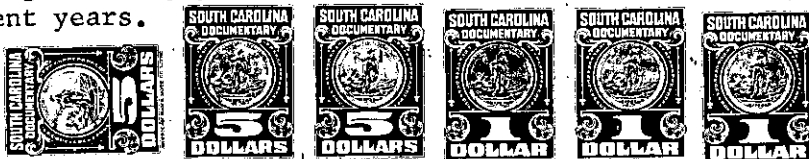
ALL that piece, parcel or lot of land together with buildings and improvements, situate, lying and being at the Northeastern corner of the intersection of Avon Drive with Thames Drive, in Greenville County, South Carolina, near Taylors, being shown and designated as Lot No. 59 on a Plat of AVON PARK made by C. C. Jones & Associates, dated November, 1956, recorded in the RMC Office for Greenville County, S. C., in Plat Book KK, page 71, reference to which is hereby craved for the metes and bounds thereof.

The above property is the same conveyed to the Grantors by deed of W. N. Leslie, Inc., recorded in Deed Book 801, page 370, and is hereby conveyed subject to rights of way, easements, conditions, public roads and restrictive covenants reserved on plats and other instruments of public record and actually existing on the ground affecting said property.

As a part of the consideration for this deed, the Grantee assumes and agrees to pay in full the indebtedness due on a note and mortgage covering the above described property given by Richard E. Parrott and Marcia S. Parrott to Cameron-Brown Company dated May 15, 1967, recorded in Mortgage Book 1057, page 423, in the original sum of \$14,400.00, which has a present balance due in the sum of \$13,414.68.

As a part of the consideration for this deed, the Grantors assign and transfer to the Grantee all their right, title and interest in and to any escrow deposits maintained by the above named mortgagee in connection with the mortgage loan covering the above described property.

The Grantee agrees to pay Greenville County property taxes for the tax year 1972 and subsequent years.
